GENERAL CONDITIONS FOR HANDLING STEEL REELS

in Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina since 01.03.2019

1. Conductors (in particular class V conductors) are sold by Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina on steel drums/reels, which are packaging not included in the price of conductors.

2. The cost of packaging is charged to the Buyer (Customer). The Seller, at the date of sale of the conductors, issues to the Buyer a separate VAT invoice, documenting the sale of packaging, for the amount resulting from the Seller's price list for steel drums/reels. The payment for the packaging is payable within the period specified in the VAT invoice.

3. The Buyer has the right to resell only steel drums/reels purchased at Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina.

4. The return of the drums/reels takes place at the expense of the Buyer.

5. Steel drums/reels must be stored in roofed rooms.

6. Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina is obliged to purchase (buy back) undamaged packaging, delivered to its premises in good condition in the period running from the date of conductor sale to the customer as follows:

a) up to 60 days – for 100% of the sale price

b) from 61 to 120 days at the sale price reduced by 20%,

c) from 121 to 180 days at the sale price reduced by 30%,

d) over 181 days - we do not accept the return of drums/reels.

7. A document confirming the delivery of packaging to Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina is a Customer's delivery note (WZ) signed by an authorized warehouse employee and returned to the Customer.

8. Each packaging (drum/reel) to resale is subject to quality acceptance Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina within 3 working days. Damage of packaging revealed during the quality acceptance is recorded in the delivery note provided by the Customer due to leaving the packaging delivered in the deposit.

9. The Customer, within 7 days of receiving such information, is obliged to declare:

a) whether it agrees to scrap the packaging by Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina at the cost of the Customer

b) whether the Customer will pick up the damaged packaging from the deposit.

10. Lack of such a declaration within the time limit referred to in point 9 and failure to collect damaged packaging within 5 days after the expiration of the above date, entitles Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina to liquidate them at the expense of the Customer.

11. Packaging is accepted in Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina on working days, i.e. from Monday to Friday, from 7 00 am to 2 00 pm. The Customer returning the steel drums/reels is obliged to agree in advance with the Sales Department of Boryszew S.A. Oddział Nowoczesne Produkty Aluminiowe Skawina a delivery date - no later than on the working day preceding the delivery day.

12. These conditions apply to deliveries related to sales from March 1, 2019
